Treasurer's Report

Annual General Meeting – 9 March 2023

Frogs Vic had a balance of \$285.18 at the time of incorporation on the 1st July 2019.

The balance at the start of last year (i.e. 1 January 2022) was \$307.82, and was \$176.44 on 31 December 2022.

The balance is currently (as of 5:30 pm!) \$346.44.

All income between 1 January 2022 – 31 December 2022 came from membership fees, amounting to **\$680.00**.

Expenditure from 1 January 2022 - 31 December 2022 amounted to \$816.38, being for:

Account fees \$65.00

Website \$483.98

End of year prizes, meals, and tokens of appreciation for guest speakers \$267.40

Funds continue to fluctuate but after increasing membership fees at the last AGM (from \$30 to \$40 for full membership), remain fairly stable overall. However, this leaves little money for irregular expenditure such as new equipment purchases.

Additional options previously canvassed for increasing funds, as well as some new ones, include:

- a) Ensure current Committee members remain financial.
- b) Send membership expiry reminders to members a few weeks before they drop off the list.
- c) Undertake a membership drive
- d) Do without our Premium website (the cost in time, however, would be substantial). It will still cost to renew our domain name, due in 2024.
- e) End buying dinner and/or tokens for speakers
- f) Avoid buying video equipment to film presentations
- g) Make membership a requirement for the mini conference (short talks) night
- h) Make membership a requirement for all events
- i) Apply for grants

Also worth exploring the cause/s of having many more people who receive the newsletter than are paying members? Could we consider if there is anything else we could provide in return for paid membership? Should we put out a survey/request feedback?
