Annual General Meeting – 6 March 2025

Frogs Vic had a balance of **\$285.18** at the time of incorporation on July 1st 2019

The balance at the start of last year (1st January 2024) was \$293.24

The balance on 31st December 2024 was \$553.90

The current balance (as of 6:30pm today) is \$875.78

All income between January 1 2024 until December 31 2024 came from membership fees, amounting to **\$1,060**

Expenditure from January 1 2024 until December 31 2024 amounted to \$797.46, including:
